*WHEREAS, the approval of the proposed Business and Budget Plan is very vital for KGI-MBA operation and it is in the best interest of the association;*


*WHEREAS, the board has reviewed the proposed Business and Budget Plan for the year 2023 and after due diligence and considerations approved the budget plan as presented;*




